Privacy Policy:

G. Robert Meger MD ("G. Robert Meger MD") operates drmeger.com and may operate other websites. It is G. Robert Meger MD's policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, G. Robert Meger MD collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. G. Robert Meger MD's purpose in collecting non-personally identifying information is to better understand how G. Robert Meger MD's visitors use its website. From time to time, G. Robert Meger MD may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

G. Robert Meger MD also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on drmeger.com blogs/sites. G. Robert Meger MD only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to G. Robert Meger MD's websites choose to interact with G. Robert Meger MD in ways that require G. Robert Meger MD to gather personally-identifying information. The amount and type of information that G. Robert Meger MD gathers depends on the nature of the interaction. For example, we ask visitors who sign up at drmeger.com to provide a username and email address. Those who engage in transactions with G. Robert Meger MD are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, G. Robert Meger MD collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with G. Robert Meger MD. G. Robert Meger MD does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

G. Robert Meger MD may collect statistics about the behavior of visitors to its websites. G. Robert Meger MD may display this information publicly or provide it to others. However, G. Robert Meger MD does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

G. Robert Meger MD discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on G. Robert Meger MD's behalf or to provide services available at G. Robert Meger MD's websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using G. Robert Meger MD's websites, you consent to the transfer of such information to them. G. Robert Meger MD will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, G. Robert Meger MD discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when G. Robert Meger MD believes in good faith that disclosure is reasonably necessary to protect the property or rights of G. Robert Meger MD, third parties or the public at large. If you are a registered user of an G. Robert Meger MD website and have supplied your email address, G. Robert Meger MD may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with G. Robert Meger MD and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. G. Robert Meger MD takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. G. Robert Meger MD uses cookies to help G. Robert Meger MD identify and track visitors, their usage of G. Robert Meger MD website, and their website access preferences. G. Robert Meger MD visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using G. Robert Meger MD's websites, with the drawback that certain features of G. Robert Meger MD's websites may not function properly without the aid of cookies.

Business Transfers

If G. Robert Meger MD, or substantially all of its assets, were acquired, or in the unlikely event that G.
